SECTION 5 - FIRE FIGHTING MEASURES

Suitable Extinguishing media: Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

Large Spills: Absorb with an inert material and put the spilled material in an appropriate waste disposal. Finish cleaning by spreading water on the contaminated surface and allow to evacuate through the sanitary system.

Handling: Do not breathe vapors or mists. Keep container closed and tightly sealed when not in use.

Storage: Store in a cool, dry, ventilated area, away from incompatible substances. Store only in approved properly labeled containers.
