SECTION 4 - FIRST AID MEASURES

SECTION 6 - ACCIDENTAL RELEASE and DISPOSAL MEASURES

Spills: Provide adequate ventilation. Avoid dust formation. Avoid breathing dust or aerosols. Suitable protective clothing should be worn. Shut off or plug source of spill.

Small spills: sweep up and collect into suitable container.
