SECTION 4 · FIRST AID MEASURES

FIRST AID PROCEDURES:

Eye Contact: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Cold water may be used. Get immediate medical attention.

Skin Contact: Remove contaminated clothing. Wash skin with soap and water. Get medical attention if irritation develops.
Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. Get medical attention if symptoms appear.

Ingestion: Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Rinse mouth with water. Get immediate medical attention.

SECTION 5 · FIRE FIGHTING MEASURES

Suitable Extinguishing media: Not considered a fire hazard. Use any means suitable for extinguishing surrounding fire.

Hazardous combustion products: Oxides of Carbon.

Fire Fighting Procedures: As in any fire, wear a self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent), and full protective gear.

SECTION 6 · ACCIDENTAL RELEASE and DISPOSAL MEASURES

Use personal protective equipment. Avoid dust formation. Avoid breathing vapors, mist or gas. Ensure adequate ventilation. Evacuate personnel to safe areas. Avoid breathing dust.

Prevent further leakage or spillage if safe to do so. Do not let product enter drains. Discharge into the environment must be avoided.

Pick up and arrange disposal without creating dust. Sweep up and shovel. Keep in suitable, closed containers for disposal.

SECTION 7 · STORAGE AND HANDLING

Handling: Keep container dry. Keep away from heat. Keep away from sources of ignition. Empty containers pose a fire risk. Ground all equipment containing material. Do not ingest. Do not breathe dust. Never add water to this product. Wear suitable protective clothing. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately. Avoid contact with skin and eyes. Keep away from incompatibles such as oxidizing agents, reducing agents, acids, moisture.

SECTION 8 - EXPOSURE CONTROLS AND PERSONAL PROTECTION

Engineering Controls: Provide explosion-proof ventilation or other engineering controls to keep the airborne concentrations of vapor or mists below the applicable workplace exposure limits indicated below.

Exposure Limits: Maleic Anhydride 0.1 ppm ACGIH 0.25 ppm OSHA

Personal Protective Equipment (PPE):

Eyes: Wear appropriate protective eyeglasses or chemical safety goggles as described by OSHA's eye and face protection regulations in 29 CFR 1910.133.

Skin: If prolonged or repeated skin contact is likely, wear appropriate protective gloves.
