## SECTION 4 · FIRST AID MEASURES

### FIRST AID PROCEDURES:

## SECTION 5 · FIRE FIGHTING MEASURES

**Extinguishing Media** Use chemical powder, water spray, fog or foam. Do not use water jet.

**Fire Fighting Procedures:** Use water spray to keep fire-exposed containers cool. Water may be used to flush spills away from exposures and to dilute spills to non-flammable mixtures.

**Fire Fighting Instructions:** In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full face piece operated in the pressure demand or other positive pressure mode

## SECTION 6 · ACCIDENTAL RELEASE and DISPOSAL MEASURES

**Small Spill:** Dilute with water and mop up, or absorb with an inert dry material and place in an appropriate waste disposal container.

**Large Spill:** Corrosive liquid. Oxidizing material. Stop leak if without risk. Absorb with DRY earth, sand or other non-combustible material. Do not get water inside container. Avoid contact with a combustible material (wood, paper, oil, clothing...). Keep substance damp using water spray. Do not touch spilled material. Use water spray curtain to divert vapor drift. Prevent entry into sewers, basements or confined areas; dike if needed.

## SECTION 7 · STORAGE AND HANDLING

**Precautions:** Keep container dry. Keep away from heat. Keep away from sources of ignition. Keep away from combustible material. Do not ingest. Do not breathe gas/fumes/ vapor/spray. Never add water to this product. In case of insufficient ventilation, wear suitable respiratory equipment. If ingested, seek medical advice immediately. Avoid contact with skin and eyes. Keep away from incompatibles such as oxidizing agents, reducing agents, combustible materials, organic materials, metals, acids, alkalis.

**Storage:** Keep container tightly closed. Keep container in a cool, well-ventilated area. Separate from acids, alkalizes, reducing agents and combustibles. See NFPA 43A, Code for the Storage of Liquid and Solid Oxidizers.
